- The Renter shall require all guests to follow all facility rules.
- NJMP shall have the right to terminate this agreement and take possession of the garages(s) for any reason, including any violation of the NJMP Facility Rules or bad conduct by any Renter or guest of Renter.
- The Renter acknowledges that the title to the garage(s) contracted hereunder shall at all times be held by NJMP.
- The Renter shall defend, indemnify and hold harmless NJMP, as well their agents, employees and affiliates, from and against all losses, damages, liabilities or expenses including, but not limited to, reasonable attorney's fees and litigation costs which any of them incur arising out of the use the garage(s) by the Renter.
- Garage reservations can be cancelled with a full refund up to 48 hours prior to the first rental morning. If not cancelled 48 hours prior to the first rental morning, Renter will pay for the full garage rental.
- The number of rental garages that Renter may be able to reserve may be limited for large event weekends.
- If paying by credit card, your credit card will be debited at time of booking.
