



PERSONAL PADDOCK VEHICLE AGREEMENT

As part of our insurance requirements, NJMP requires that all Personal Paddock Vehicles (PPV) (i.e., golf cart, pit bike, ATV, etc.) or other unlicensed off-road vehicles used at NJMP maintain a valid NJMP credential displayed on the vehicle and a copy of this agreement on file with NJMP staff. In consideration for being permitted to use and operate the Personal Paddock Vehicle on NJMP premises at any event or activity, the vehicle owner and/or competition entrant:

- Hereby assumes full responsibility for and assumes the risk of bodily injury, death, or property damage arising out of or related to the use of said vehicle whether caused by the negligence of owner and or their operators, NJMP, other PPV operators or otherwise. In particular, owner shall reimburse NJMP for any damage to NJMP property caused by the PPV at NJMP.
- Hereby acknowledges and agrees that all operators of the PPV shall be at least **18 years old** and that owner will carry liability insurance applicable to the operation of the PPV and that said insurance shall be primary should any claim arise from the operation of the PPV.
- Hereby acknowledges that the use of the PPV is dangerous and involves risk of serious injury and/or death and/or property damage.
- Hereby agrees that the PPV will be operated in a responsible manner and according to all additional NJMP regulations and instructions, including but not limited to posted speed limits, designated roads and hours of operations, and limitations on when and where the PPV may be operated.
- Hereby agrees that the PPV will not be operated outside designated paddock areas.
- Hereby agrees that the PPV will not be operated on grass areas in any way that damages any grassy surface (for example, no tearing up the grass in any paddock area).
- Hereby acknowledges that unsafe and improper operation of the PPV and/or any violation of rules and regulations and instructions may, at the sole discretion of NJMP, result in penalties against the owner and/or operators including but not limited to immediate impounding of the PPV, removal of the owner/operator from the premises, loss of racing privileges for the event for a first offence, and for the season for the second offence.
- If paying by credit card, your credit card will be debited at time of booking.
